The State Organization of Georgia shall be a subsidiary of the Seventh District of the OMEGA PSI PHI FRATERNITY, INC., and shall be known as the Seventh District State Organization of Georgia, Omega Psi Phi Fraternity, Inc. or whatever name is directed by the Seventh District and comprised of Chapters in the State of Georgia. The mission of this organization shall be to promote the ideals of the Fraternity and to serve as a link between the International Headquarters, the Seventh District and the Chapters located within the borders of the State of Georgia. The State Organization will assist Chapters with: (a) Keeping alive the interest of the Chapters. (b) Providing a medium of expression for Chapters in the State of Georgia. (c) Consider and assist Chapters with issues peculiar to the State of Georgia. (d) Coordinate activities in the state of Georgia.

In my final year as your State Representative, this was a year that under normal circumstances would be unfathomable, however, this is The Georgia State Organization and where others are ordinary, we are extraordinary. Once again, I am elated about the progress and accomplishments of the brothers and chapters in our great state. When others shut down during the pandemic, our brothers stepped up. When others said we can't do that, our brothers said, how can we do more? In our efforts to do more, The State Organization of Georgia, our chapters and our brothers went above and beyond the call of duty and when you put out that type of effort, you get recognized, and again, although awards are not our goals, but I am happy to report that of 10 Major award categories, the 7<sup>th</sup> District won 9 awards and of that 9 the State of Georgia won 5 of those. Again, we maintained a financial membership of over 2500 brothers, and depending on whose numbers you look at, over 3,000 brothers financial at some level. 2021-22 will forever be remembered as a year of **VICTORY Part II!!!** In the Great State of Georgia, we were able to accomplish much, highlighted by the following:

At the 83<sup>rd</sup> Grand Conclave in Charlotte, NC, the 7<sup>th</sup> District won 9 of the 10 Major Achievement Week Award Categories, Georgia won 5 of those:

This effort involved partnering with other chapters as well as other organizations in the community with the same focus. With students returning to school, the need for scholarships were priority. The top chapter awarded \$40,000 in scholarships followed by \$30,000 as the next highest award. Mandated programs continue to be Omega's guide, and I was ecstatic to see the efforts put forth despite the lingering challenges of COVID.

The undergraduate chapters continue to work toward meeting the standard set forth by our founder's. With education being priority, PSI, Kappa Kappa, and Beta Psi chapters were able to navigate to COVID to have another successful academic year upheld through service on and off campus. The creativity and enthusiasm of young brothers emphasize the need for continuous mentoring to undergraduate chapters. They are the lifeline of our fraternity, and with consistent leadership and partnering, Omega will continue to be leaders throughout the world.



These forums can be the springboard to leverage thought leadership among both organizations.
